MINUTES JANUARY 30, 2011

CHAIRMAN AL opened the meeting with a moment of silence followed by the serenity prayer.

SECRETARY'S REPORT:- minutes of last meeting were accepted as read.

TREASURER'S REPORT:- John L. reported that an annual audit was conducted by trustees and that revenues were seriously down for last year. John presented a printout of financial affairs. He motioned that a loss of \$48.00 from the alkathons be paid out of existing expense fund. The motion was accepted. John's report was accepted.

TRUSTEES REPORT:- John W, Martha G and Paul B had nothing to report. Darral M reported that the audit at the bookstore was successful.
