

NATURE COAST INTERGROUP
MEETING MINUTES
MARCH 27th, 2011

CHAIRMAN AL opened the meeting with a moment of silence followed by the serenity prayer.

SECRETARY:- Denis S. read minutes of previous meeting and they were accepted as read.

TREASURER:- John L. reported that there was a profit of \$609 for the month due to increased donations. He reported that the rent has been paid for the next three month period. He reported that we have \$6892.91 on hand. He also reported that we received a new phone bill bringing the total overage on the hotline phone attributed to the past hotline chair to \$498.98. He made a motion that we table discussion of this matter for two months to await developments. The motion was passed unanimously. The treasurer's report was accepted.

TRUSTEES:- John L, Paul B, Darral M and Martha G. had nothing to report.

INVENTORY AND SALES:-Darral M said that we had a good month and that he is looking forward to keeping the doors open.
