

### **Standing Committee Reports: -**

Hotline: - Absent, no report submitted.

**Web:** - Steve N.- Ncintergroup.com was visited 4933 times in July by 3067 unique visitors viewing 9060 pages or an average of 1.9 pages per visit, the bounce rate was 44.96% well below the goal of being lower than 60%. The audience was 78% returning visitors and 22% new visitors. 56.2% were male and 43.8% female. 9.09% were ages 18-24, 16.53% were ages 15-34, 13.22% were 36-44, 20.66% were 45-54, 21.49% were 55-64 and 19.01% were 65 or older.

The ten most visited pages after the start page were Where and When, AA History, Monday Meetings, Meetings General, Workshop Topics, Meetings by Day, Journal, Meeting by Location, Calendar and Traditions MP4. The most downloaded pages were Where and When, Calendar, Journal, Responsibility Statement, AA History, Workshop Topics, legacies, Grapevine information, 12 Questions and Hot Line Phone number. Thank you for allowing me to serve, Steve N.

**Journal**: - Sue S. – Brought the August/September Journal hot off the press. She needs more anniversary dates from the groups and asked for a list of all GSR's to make contact. She mentioned that she is trying a different software, to make the Journal more professional, more will be revealed. A major order of business is outlined in Amendment Seven of the Nature Coast By-laws. It reads:

#### "AMENDMENT SEVEN

Article Six-Elections: Officers & Trustee elections will be held bi-annually in October of even years. Nominations of Officers & Trustees shall be submitted @ the September meeting of even years and published in the N.C. I. monthly Newsletter. Additional nominations may be submitted the day of the elections. New Officers & Trustees term will begin at the January annual meeting following the elections."

In other words, you will soon be standing for and electing officers and trustees for panel 69 and Nature Coast Intergroup needs people to stand up and submit their resumes for service so the "hand of AA.) in this district will always be there. I have passed out on the table today Resume forms for service. Please pick one up.

Bill Wilson spoke in 1955 at the St. Louis Convention where "Recovery, Unity, and Service" were introduced as the three legacies of A.A. given to the whole membership by its founders and other old timers. In other words, at that convention the responsibility for AA's continuation and growth was turned over to all of us. Bill said, "these services... are utterly vital to our existence and growth."

In his farewell talk, Dr. Bob said "Our twelve steps, when simmered down to the last, resolve themselves into the words 'love' and 'service.' We understand what love is, and we understand what service is. So, let's bear those two things in mind... So, let us never get such a degree of smug complacency that we're not willing to extend or attempt to extend to our less fortunate brothers that help which has been so beneficial to us."

I testify to you that service years have saved my life and kept me sober. We need each and every one of you to step in whatever way you can in order to continue the work begun by Bill and Bob. Please consider learning some new skills and helping Nature Coast Intergroup grow and be there in the future for the still suffering alcoholic.
